Welcome to El Porvenir, New Mexico! This document is meant to inform you of current conditions and procedures during your stay.

## **Covid 19 Information**

- New Mexico is under a public health order due to the Covid-19 pandemic. We expect El Porvenir guests to follow the NM Covid-Safe Practices during their stay. The requirements include the following:
  - Individuals must wear masks while in public
  - Individuals who travel to NM from out of state must self-quarantine in their place of lodging for 14 days
  - Individuals who are exposed to those who are self-quarantining must themselves self-quarantine for 14 days
  - Individuals must avoid gatherings of more than 4 people
  - Individuals may not host members of other households in their place of lodging
  - Individuals who violate these rules, and businesses who fail to enforce these rules, each face a possible \$100 fine per incident
- If you feel sick while at El Porvenir or within 14 days of returning home, contact an El Porvenir staff member about your symptoms. Email Nate at nate.stafford@elporvenircamp.com.
- In the event of a positive Covid-19 test of any present or past guest or EPCC staff member or volunteer, contact tracing will need to be performed. Keep a note of your interactions while at El Porvenir. Persons entering the property must provide name, address and phone number.

## **During Your Stay**

- We expect guests to stay out of buildings that have not been assigned to them.
- No public restrooms are available.
- If you need an El Porvenir staff member, chat with us through our website at elporvenircamp.com (click the small green icon in the lower left on any page) or use a provided camp radio to make contact. Please avoid in person contact with El Porvenir staff and their families.
- Your lodging space has been cleaned and sanitized for you, outdoor surfaces generally have not been sanitized unless otherwise indicated. Please keep your personal items separate from EPCC's and other guests' items.

## **Other Current Conditions**

• The Santa Fe National Forest is in stage 2 fire restrictions. No smoking or campfires are allowed on camp property or in the National Forest. Fireworks are never allowed.
